Terms of Use

By accessing or using the MAIN website, the MAIN service, or any applications (including mobile applications) (together referred to as the "Service") made available by MDK TECHNOLOGIES LTD incorporated in Cyprus with company registered number 383998 whose registered office is at Achaion 35, 5th floor, Flat/Office 17, Agios Andreas, 1101, Nicosia, Cyprus, (hereinafter: «MAIN», «MDK» «we» «our» or «us») however accessed, you agree to be bound by these terms of use (hereinafter referred to as the "Terms of Use" or Terms). These Terms of Use affect your legal rights and obligations. If you do not agree to be bound by all of these Terms of Use, do not access or use the Service.

1. Who may use the Services

You must be at least 13 years old and shall not be a resident of the United States of America to use the Services.
